SHARPER FOCUS NEEDED ON FUNDING AND MONITORING OF ARM'S LENGTH ORGANISATIONS

Comptroller and Auditor General issues latest report

Comptroller and Auditor General (C&AG), Karen McConnell, has today (6 December 2018) published a report on Arm's Lengths Organisations (ALOs) focussing on Visit Jersey.

The States have a large number of ALOs with a range of responsibilities and accountability arrangements. In 2017 the C&AG published a report, *Oversight of Arm's Length Organisations*, in which she identified weaknesses in the States' arrangements. Following that review she decided to include further work on ALOs in her work programme, focussing on individual ALOs. Visit Jersey is the first of these reviews.

Visit Jersey was established in 2015 and is one of the larger ALOs. Its mission is to promote tourism both to and within Jersey in an innovative, economic and efficient way. It is funded through an annual grant of approximately £5 million. It has an establishment of 14 staff and is governed by an independent Board.

Karen McConnell concluded that the best outcomes for the Island will be achieved if the States sets relevant targets for ALOs in the context of clear strategic objectives. In the case of Visit Jersey targets were agreed, but these were not clearly linked to the States' strategic objectives and there should have been more effective challenge before the targets were agreed.

She also concluded that the States' approach to the oversight of Visit Jersey has developed in response to the findings in her 2017 report on the *Oversight of Arm's Length Organisations*. She found that a more structured approach had been adopted, with documented assessments against relevant factors and better defined roles for officers. She welcomed those developments but also identified that more needed to be done to ensure the changes were properly implemented.

Within Visit Jersey she found that the arrangements for corporate governance and monitoring performance were generally well developed for an organisation of its size. However, she identified scope for improvement in some areas of corporate governance and in performance management.

Karen McConnell said:

"Best value for money for the Island is secured when the States have clear objectives and link funding to the achievement of measurable outcomes. This demands rigour in monitoring delivery and a constructive partnership approach with a well-governed ALO. Progress has been made but there is more for the States and Visit Jersey to do.

"Many of my findings and recommendations apply to other ALOs and, indeed, to the funding of ALOs overall, as the funding of one ALO cannot be considered in isolation. I recognise that the States, as part of the move to a new Target Operating Model, have appointed senior staff with an enhanced focus on partnerships. This gives an opportunity to strengthen the States' approach across a wide range of ALOs, including Visit Jersey.

"In my report I have made some initial observations on the remuneration of the Visit Jersey Board. I am currently undertaking a wider piece of work looking at arrangements for determining remuneration for Board members of States-owned entities and ALOs. I plan to report the conclusions from that work in 2019."
