23/20 Item 1: Declarations of interests

The Board received a report from the Secretary to the Board.

Rob Tinlin highlighted changes to his interests.

The Board agreed that the Register of Interests should be updated to reflect these changes and that the updated Register should be published on the Jersey Audit Office website.

23/21 Item 2: Chair's update

The Chair welcomed the Board Apprentice, Christopher Alexander to his first Board.

In response to an invitation by the Chair, the Comptroller and Auditor General, as Chair of the Recruitment Panel, provided an update on the recruitment of a new Deputy Comptroller and Auditor General.

23/22 Item 3: Minutes of the meeting held on 22 March 2023

The Board received and agreed to adopt the minutes of the meeting of the Board held on 22 March 2023.

23/23 Item 4: estimates for the Office of the Comptroller and Auditor General

The Board received a report from the Finance Officer containing details of the:

- forecast budget outturn for 2023
- requirements for the Government Plan 2024 to 2027
- preparation of estimates for inclusion in the Government Plan 2024-2027
- estimates for inclusion in the Government Plan 2024 2027.

The Board noted the estimated levels of inflation used in preparing the estimates and reviewed the level and extent of additional investments required over the Government Plan 2024 - 2027 cycle.

The Board:

- noted the report
- approved the estimates prepared by the Comptroller and Auditor General
- agreed level and extent of investments required within the period covered by the Government Plan 2024-2027
- agreed that the investments required should be sought within the earliest Government planning cycle as deemed appropriate by the States of Jersey.

23/24 Item 5: Jersey Audit Office Policies

The Board received and considered a report from the Comptroller and Auditor General which provided an update on:

- her assessment of whether internal audit would strengthen internal control of the Comptroller and Auditor General's activities
- the progress on developing an Information Policy incorporating an approach to guard against cyber risks; and
- the review of the Equal Opportunities policy.

The Board:

- noted the report; and
- agreed in principle the approach set out in the report to guard against cyber risks.

23/25 Item 6: Risk Register

The Board received and discussed the risk register and a report from the Secretary to the Board highlighting the key changes made to the risk register since the last Board of Governance meeting.

The Board:

noted the changes to the risk register; and

 highlighted risk R04: Compliance with the Jersey Tax regime. The Board raised its concerns about the additional cost pressures that may arise and the impact on Comptroller and Auditor General budget responsibilities. The Board noted that the Comptroller and Auditor General had raised the matter with the Treasurer of the States and that further information is awaited.

23/26 Item 7: Board member recruitment update

The Board received a report from the Secretary to the Board outlining progress on the recruitment of a new Board member.

The Board:

- noted the report
- agreed that no additional knowledge or skills were required over and above the person requirements agreed by the board in March 2023
- approved the shortlist of recruitment specialists to be approached for quotes for service
- agreed the proposed revised timing of the appointment process.

23/28 Item 9: Comptroller and Auditor General's report

The Board received a report from the Comptroller and Auditor General focussing on:

- reports issued and planned. The Comptroller and Auditor General highlighted the webinar planned on the draft Code of Audit Practice consultation and on her mid-term reflections
- appointment and monitoring of financial statements auditors, including the completion of the 2022 audit
- interaction with the States Assembly, including the current series of Public Accounts Committee hearings
- developments within the States of Jersey, including the appointment of a new Interim Chief Executive and developments within Health and Community Services
- developments within the Jersey Audit Office; and
- external engagement.

The Board:

noted the report; and

 extended its thanks to the Comptroller and Auditor General, her Core Team and her Affiliates for the additional work they had undertaken in the absence of a Deputy Comptroller and Auditor General.

23/28 Item 10: Audit quality framework

The Board received a report from the Deputy Comptroller and Auditor General detailing:

- procedures for gaining assurance on the quality of 2022 financial statement audits
- reporting the completion of the audit of the financial statements of States of Jersey and on the status of the audits of other bodies to which the C&AG appoints auditors
- progress on implementing INTOSAI principles and standards

The Communications officer joined the meeting.

23/29 Item 11: External communications

The Board welcomed the Communications Officer to the meeting.

The Board received a report from the Communications Officer covering:

- media and stakeholder activity;

The Communications Officer highlighted in particular:

- work on stakeholder engagement, including in connection with the project on Annual Reporting;
- discussions with the Government of Jersey on media engagement;
- continuing press interest in the work of the Office; and
- ongoing consideration of the potential use of an accessibility widget.

The Board noted the report, welcoming the ongoing interest in the work of the Office.
