Jersey Audit Office Awards for Transparency and Excellence in Annual Reporting

The Jersey Audit Office (JAO) has recognised seven entities for their commitment to Transparency and Excellence in Annual Reporting.

Awards have been made as part of the 20th anniversary of the Office of Comptroller and Auditor General (C&AG) for Jersey. The C&AG has also published her updated **Annual Reporting Good Practice Guide** designed to support organisations in developing their public annual reporting.

Every year since 2020 the JAO has reviewed the annual reports of around 40 States owned and States established entities against best practice criteria it has established and developed. This year the JAO reviewed the 2024 annual reports of 43 entities. Exhibit 1 summarises the areas considered as part of the review.

Back in 2020 the C&AG found that, of the 40 annual reports she considered from 2019, just six were considered to be 'fair' with none judged as 'good' and the remainder judged as 'poor' or 'very poor'. In each year since the C&AG has seen improvements with more and more entities taking on board her recommended practices. This year, 28 out of the 43 annual reports reviewed from 2024 were judged to be 'good' or 'fair' against criteria updated to emphasise the importance of holistic reporting including sustainability reporting.

Awards have been issued in eight categories:

 - o Winner: Jersey Development Company
 - o Runners up: Digital Jersey, Jersey Office of the Information Commissioner
- Best Remuneration & Staff Reporting (Large Entities)
 - Winner: States of Jersey
 - o Runners up: Jersey Electricity, Ports of Jersey
- Best Sustainability Reporting
 - o Winner: JT
 - Runners up: Jersey Development Company, Jersey Electricity, Ports of Jersey, Jersey Water
- Going Above & Beyond in Annual Reporting
 - o Winner: Jersey Advisory and Conciliation Service
 - o Runner up: Jersey Resolution Authority
- Best Annual Report (Small/Medium)
 - o Winner: Jersey Development Company
 - Runners up: Jersey Care Commission, Jersey Competition Regulatory Authority



- Best Annual Report (Large)
 - o Winner: Jersey Water
 - o Runners up: JT, States of Jersey

Lynn Pamment CBE said:

"First and foremost, transparency in annual reporting is essential for building and maintaining public trust. Each year, the entities we have reviewed are entrusted with significant sums of money from Islanders whether that be through taxation, government grants and contracts or charging citizens for the delivery of vital services. When entities report in a fair, balanced and understandable way on their finances, activities, and outcomes, they demonstrate respect for the people they serve and foster a culture of trust. Islanders are more likely to have confidence in entities that are forthcoming about their successes, challenges, and use of resources.

"When annual reports are accessible and understandable, Islanders are empowered to ask questions, provide feedback, and are better placed to contribute to shaping future priorities.

"Transparency in annual reporting is not a bureaucratic exercise. It is a vital practice that underpins public trust, accountability, efficiency, compliance, and engagement. It is the means by which the States of Jersey, States controlled entities and States established entities demonstrate their commitment to and success in serving the public interest."
